GENERAL INFORMATION

Journey™ HSOC was developed to maximize the effectiveness of post emergence herbicides

DIRECTIONS FOR USE

Journey™ HSOC may be used as recommended on this product label. Check the pesticide label for specific crop use, and timing of application.

Application Rates

Apply at a rate of 0.50% V/V (5L Journey™ HSOC/1000 L spray mixture). When applied as a tank-mix combination, read and observe all label directions, including rates, personal protective equipment, restrictions and precautions for each product used in the tank-mix. Always use in accordance with the most restrictive label restrictions and precautions.

MIXING INSTRUCTIONS

SHAKE WELL BEFORE USING. Always add Journey™ HSOC adjuvant to the spray mix last and continue agitation or follow specific tank filling and mixing information provided on the herbicide label.

DIRECTIONS FOR USE

The rate of Journey™ HSOC is indicated for the control product spray mixtures or other uses listed below. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products.

- When using spray volumes less than 93.54 L/ha, do not apply Journey™ HSOC at less than 469 ml/ha.

DO NOT apply using aerial application equipment.

As this product is not registered for the control of pests in aquatic systems, DO NOT use to control aquatic pests.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes, skin or clothing. Do not get in eyes, on skin, or on clothing. Wear a long-sleeved shirt, long pants, chemical-resistant gloves, socks and shoes during mixing, loading, application, clean-up and repair. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Treat symptomatically.

STORAGE

Do not store near heat or open flame. Store in a dry location. Storage above freezing is recommended. If product freezes, warm and agitate (recirculate) prior to using. Store this product away from food or feed.

DISPOSAL

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

CONTAINER DISPOSAL:

For recyclable containers:

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.
