SECTION 2: HAZARDS IDENTIFICATION			
<b>EMERGENCY OVERVIEW:</b> Clear pink to tea brown liquid with slight organic odor. Causes serious eye and skin damage. May cause burning of the esophagus.

**SECTION 4: FIRST AID MEASURES**

<b>Inhalation:</b>	Remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation occurs.

**SECTION 5: FIRE FIGHTING MEASURES**
